All multidisciplinary team members are actively supported with their professional development specific to Youth work
 - ➤ The team has been through some significant change processes including facing the risk of losing its role in entirety. This exciting rejuvenation and expansion from 0.5 EFT, which it was reduced to from a fully functioning team at one point, to current ~15 EFT team included strategic work around new governance structures, Model of Care and orientation and support of new clinicians and LE workforce.
 - This includes development of business cases for active recruitment along with provision of leadership to the Senior Medical Staff.
- Establishing Peninsula Health as an Infant Child and Youth (0-25 years) Area Mental Health and Wellbeing Service

- In response to the Royal Commission recommendations, I am co- leading the design and establishment of a 0-25 age group service for Victorians living in the Frankston and Mornington Peninsula communities.
